UNIVERSITY COOPERATION AGREEMENT

In Barcelona, on 21st September, 2019

BETWEEN

Of the one part,

Carlos Giménez Gómez and Manel Rovira Guerin, acting for and on behalf of the following companies: **EAE INSTITUCIÓN SUPERIOR DE FORMACIÓN UNIVERSITARIA, S.L.**, through the attended training section **EAE BUSINESS SCHOOL** (hereafter referred to as **EAE**) and through the online training section **ONLINE BUSINESS SCHOOL** (hereafter referred to as **OBS**); **UNIVERSITAT INTERNACIONAL VALENCIANA - VALENCIAN INTERNATIONAL UNIVERSITY, S.L.** (hereafter referred to as **VIU**); **UNIVERSO ESTELAR, S.L.**, proprietor of the Barcelona International University Centre (hereafter referred to as **UNIBA**), **CENTRO SUPERIOR DE ALTOS ESTUDIOS INTERNACIONALES, S.L.**, operating commercially as **OSTELEA** and **ESDESIGN** (Escuela Superior de Diseño de Barcelona) (hereafter referred to as **OSTELEA** and **ESDESIGN**); **THREE POINTS EDUCATION S.L.**, operating commercially as **THREE POINTS** (hereafter referred to as **THREE POINTS**).

Hereunder, **EAE, OBS, VIU, UNIBA, OSTELEA, ESDESIGN** and **THREE POINTS** can be referred to jointly as **PLANETA TRAINING UNIVERSITIES**.

And of the other part,

RIMT University (hereafter referred to as **RIMTU**), duly constituted, with headquarters in Mandi Gobindgarh, Punjab, registration number 31 of 2015 Punjab State Act and represented for this **UNIVERSITY COOPERATION AGREEMENT** by Dr. A.S.Chawla, Vice Chancellor of the University.

Hereunder, **PLANETA TRAINING UNIVERSITIES** and **RIMT UNIVERSITY** can be referred to jointly as **THE PARTIES**.

The purpose of this agreement is to promote and broaden international development and understanding by supporting educational, professional and intercultural activities and projects among the students, professors and administrative personnel of the participating institutions.

The participating parties, recognising their capacity for the formalisation of this instrument, declare their mutual interest in signing a **UNIVERSITY COOPERATION AGREEMENT** in the following terms:

PLANETA TRAINING UNIVERSITIES declares:

- a) That it is a group of universities and higher education centres belonging to the **PLANETA GROUP** and its mission is to give a response to the training needs presented and demanded

by society in the financial, legal and business world.

RIMT University declares:

- a) That it is an institution of a technical-scientific and educational character legally authorised by the corresponding national laws to impart its training services and operate fully at national and international level.
- b) That its object is to administrate and direct all kinds of activities in education, scientific research and the dissemination of culture. Therefore it can teach in higher education and in any other class which is related to its object. It can also promote and carry out research in the science and technical fields.

THE PARTIES declare:

- a) That within the respective educational policies they are interested in obtaining inter-institutional cooperation by the use of common services and employment of the structural and human resources existing in the participating institutions.
- b) That they propose, by partial agreements, to establish forms of cooperation which contribute to achieving their shared objectives of teaching, research, the supply of services and the exchange of scientific, technological and cultural information.

For all the above, they agree to enter into this framework collaboration agreement, in accordance with the following clauses:

One – Purpose:

The general purpose of the Agreement is to encourage cooperation between THE PARTIES in the fields of teaching, research and extramural studies in those areas in which the parties have a manifest interest, and to promote international understanding through educational, professional and intercultural activities and projects among the students, professors and administrative personnel of the participating institutions.

Two – Activities:

To achieve the purposes set out, THE PARTIES propose as a shared goal the carrying out of the following activities:

- Exchange of teaching staff for their various academic and extramural study programmes, provided that it is possible and in accordance with the conditions established ad hoc between THE PARTIES.



Special promotion of stays for teachers and researchers for determined periods with the aim

of giving lectures, taking part in courses and in the development of shared teaching programmes.

- Exchange of students for their various academic and extramural study programmes in accordance with the conditions established between THE PARTIES and the number of places set for each programme.
- Joint research with the exchange of results.

Three - Grants and financial aid:

THE PARTIES undertake to offer a programme of grants and financial aid to the students and former students who wish to take part in the academic programmes and courses offered by THE PARTIES.

Four - Joint academic activities:

Joint programming for the undertaking of academic activities, such as seminars, courses, workshops, postgraduate programmes and, with special interest, combined Master and postgraduate qualifications.

To carry out these activities specific agreements will be signed to develop this framework agreement, determining the content of the courses, financial conditions, number of participants, teaching load of each institution, etc.

THE PARTIES will apply their best efforts to reciprocally acknowledging the validity of the qualifications granted by each of them, at both graduate and postgraduate levels.

Five - Information:

THE PARTIES will inform and introduce to their students, former students, academic staff and administrative personnel the existence of this framework agreement and all the activities which are developed jointly.

Also THE PARTIES will collaborate in the holding of informative sessions with the aim of informing groups who may be interested in the various activities being organised.

Six - Other Activities:

To promote the carrying out of other academic and joint research activities of mutual interest for the development of each institution.

The definition of each of the activities proposed will be formalised in a specific separate agreement which will be revised, approved and signed by THE PARTIES and will be attached to this framework agreement.

Seven - Management and Coordination of the Agreement:

The management and coordination of this agreement is in the competence of the respective managers, or those to whom it is delegated, assisted by the International Departments, who take part in its implementation and execution.

THE PARTIES undertake to maintain continuous communication through their respective departments with the aim of increasing cooperation between them and developing as many activities as possible.

Eight - Duration:

The initial duration of this agreement will be for 3 years starting from the date of its signature.

The agreement will be automatically extended for periods of the same duration unless either party informs otherwise in writing with one (1) month in advance of the initial expiration date or any of its extensions.

Nine - Financing:

On defining each specific activity under this framework collaboration agreement, the corresponding financing must be established and agreed.

Ten - Dissemination of the Agreement:

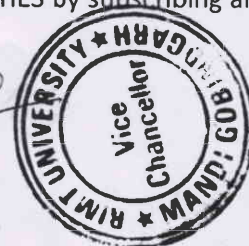
Given the international character of RIMT UNIVERSITY and our institutions (EAE, OBS, VIU, UNIBA and OSTELEA), THE PARTIES will undertake to disseminate the existence of this Agreement through their respective websites and information channels.

The trademark or logo and emblems of both parties will be used exclusively in the version that facilitates each one of them to the other, without it being possible to alter colours, forms, symbols or graphics.

Eleven – Extension of the Agreement:

The present agreement allows the extension of this collaboration to other educational institutions that become part of the division PLANETA TRAINING UNIVERSITIES by subscribing an annex to this framework agreement.

REVISING THE AGREEMENT

This Agreement can be revised by the parties at any time within the constitutional and legal framework of the respective countries and the Constitutions of the signatory Institutions.

All those difficulties which may arise in the application of the agreement and in collaboration between THE PARTIES will be resolved by the parties in good faith and by common accord.

The parties being in agreement with the content and scope of all the above clauses, they sign this document in duplicate and for one sole purpose, issued in four copies.




