The Hospital and the University agree to further sign exclusive MoU for specific courses which will be identified after market assessment, mutual agreement & consensus.

- RIMT University will join hands with Mohandai Oswal Hospital of the usage of its clinical complex for running OPD as per mutual agreed terms & conditions
- g) RIMT University will issue proper log book to all interns with key learning objectives well-defined
- RIMT University/Mohandai Hospital will depute faculty/lecturer/tutor for assessment & academic learning of identified disciplines after mutual agreement.
- University also in agreement comprises batch size of not more than 5 interns per discipline for better academic learning & hand-on training.
- j) The course fee and the share of the University as well as the Hospital shall be formulated and implemented on actual basis for individual courses as may be drafted and agreed upon by working group from both the parties.
- k) That during the course of training at the Hospital, the trainees will honor, respect and comply to the policy guidelines of Mohandai Oswal Hospital.
- I) That disputes/disciplinary issues related to the students at Hospital, if any, shall be immediately brought to the notice of RIMT University by the hospital authorities for needful actions. Entry of such defaulters to hospital may be restricted as per the policy and as may be deemed desirable.
- m) The trainees may be required to be deployed in shifts for appropriate learning, smooth administrative & technical functioning of the department.
- n) The transportation, lodging & boarding, food expenses etc. shall be required to be borne by the students / RIMT University, as may the case be.
- The responsibility of the hospital shall solely be that of providing infrastructure & services for the purpose of training. All other affairs related to the students/trainees including the faculty shall be the sole responsibility of the university unless agreed upon separately for individual course.
