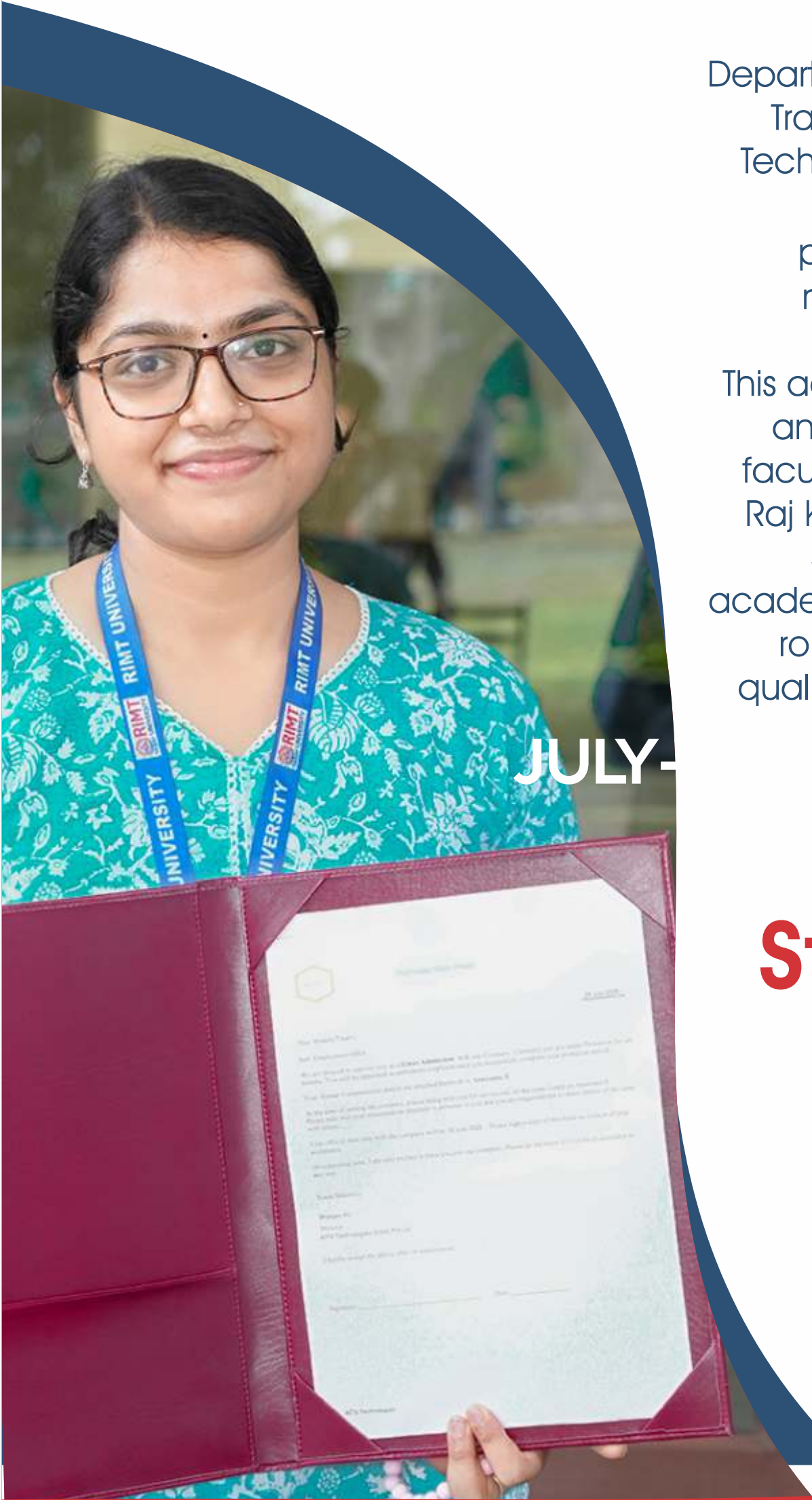

A Study on Customers impulse buying behavior in organized retail stores in Punjab

The research study provides a comprehensive introduction to the retailing landscape, with a particular focus on India and the phenomenon of impulse buying. It begins by defining "retail" its etymological roots, functions, and the retailer's role as the critical intermediary between producers and end consumers. The chapter then situates Indian retail within its historical and cultural context, tracing its evolution from ancient bazaars through colonial-era department stores, post-independence kirana outlets, economic liberalization in the 1990s, and the rise of e-commerce in the 2010s. Key milestones include the entry of organized chains such as Shopper's Stop and Big Bazaar, the liberalization of FDI norms, and the proliferation of digital payments and omnichannel strategies.

Next, the study examines the contemporary Indian retail market, highlighting its dual structure of organized and unorganized formats, rapid growth projections, and regional dynamics particularly the robust consumption environment in Punjab, driven by high per capita income, strong infrastructure, and balanced urban-rural demand. Market metrics such as outlet density, retail space per capita, and sectoral contributions to GDP underscore both the opportunities and challenges facing retailers.

Central to the study is an in-depth exploration of impulse buying. Definitions and theoretical models (including Stern's typology of impulse purchases) are presented alongside analyses of internal motivators hedonic needs, self-identity, and impulse-buying tendency and external triggers such as store atmospherics, layout, displays, and promotional cues. The chapter identifies four atmospheric dimensions (visual, aural, tactile) and details how stimuli at point-of-sale can elicit unplanned purchase decisions.
